4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Emergency Precautions:

Personal precautions, protective equipment and emergency procedures Wear suitable protective clothing, gloves, and eye/face protection. Evacuate all unnecessary personnel. Increase ventilation. Use clean,

non-sparking tools and equipment. Absorb onto dry sand or similar inert material an place in recovery containers for disposal. Avoid release to the environment.

Environmental precautions:

Do not allow to enter drainage system, surface, or ground water. Dilute with plenty of water.

Methods and Materials for Containment and Clean Up:

Soak up spilled product using absorbent, non-combustible material such as sand or soil. Avoid using sawdust or cellulose. When saturated, collect material into suitable, labelled, dry, sealable containers and hold for safe disposal. Once pickup is complete, flush spill site with plenty of water to eliminate any residue. Hold contaminated water for treatment/disposal.
